Updated New Holland Borough Schedule of Fees

Building Permits	<ul style="list-style-type: none">A. \$20 administrative fee for any Permit including Demolition Permits, not requiring inspection.B. For all other permits, the Administrative fees shall be as follows. This does not include all other UCC fees, plan review and inspection costs:<ul style="list-style-type: none">1. for a permit value between \$1.00 and \$49,999, a \$35 administrative/zoning fee.2. for a permit value between \$50,000 and \$99,999, a \$60 administrative/zoning fee.3. for a permit value \$100,000-\$199,999 a \$120 administrative/zoning fee.4. for each additional \$100,000 in value over \$199,999, an additional administrative/zoning fee of \$125 per \$100,000 in value, not to exceed \$500 for a total administrative/zoning fee.

Rental Application Fees	<ul style="list-style-type: none">A. \$25 for every apartment including bed and breakfast rooms in the Borough for 3 years or change in property ownerB. \$3 per hotel/motel room in the Borough for 3 years

Zoning Hearing Fee	\$500 Variance \$400 Special Exception

Conditional Use Application/ Hearing	\$500—A use that, owing to some special characteristics attendant to its operation or installation is permitted in a district subject to approval by Borough Council and subject to special requirements and/or conditions.
Petition for Zoning Map Amendments (Rezoning); or Curative Amendment Request	\$500—A request to amend the official Zoning Map and/or Ordinance of New Holland Borough, which sets forth the boundaries or uses within a zoning district which may pertain to certain zoning and/or development regulations.
Subsequent Hearing Fee	\$350—Fee for each subsequent Conditional use and/or map amendments to cover administrative costs and any applicable public notifications.


