ORDINANCE NO. 576

**AN ORDINANCE TO AMEND THE CODE OF ORDINANCES
OF THE BOROUGH OF NEW HOLLAND, BY AMENDING
CHAPTER 16 (PARKS AND RECREATION) TO UPDATE THE
HOURS FOR BOROUGH PARKS**

NOW, THEREFORE, IT IS HEREBY ORDAINED AND ENACTED by New Holland Borough, Lancaster County, Pennsylvania (herein "**Borough**"), that the *Code of Ordinances of the Borough of New Holland* (herein "**Code**"), Chapter 16 (Parks and Recreation), is amended as follows:

Section 1. Code Chapter 16 (Parks and Recreation), Section 102 (Park Hours) of the Code is repealed entirely and replaced with the following:

§102. Park Hours. All parks in the Borough of New Holland shall be open daily between the hours of 6:00 a.m. and 9:00 p.m. for the months of March through October, inclusive, and shall be open daily between the hours of 6:00 a.m. and 6:00 p.m. from November through February, inclusive. No person (other than police, security guards, law enforcement persons, or other persons authorized by the Borough Council, Borough Council President, or Borough Manager) shall occupy, frequent, or use any park for any reason between the hours of 9:00 p.m. through 6:00 a.m. the following day during the months of March through October, nor from 6:00 p.m. through 6:00 a.m. the following day during the months of November through February, except when a park is being used for supervised special events, entertainment, athletic contests, or similar activities that have been pre-approved by the Borough Council, Borough Council President, or Borough Manager. Notwithstanding the foregoing, all tennis courts, field hockey areas, and basketball courts shall be open and may be utilized twenty-four hours a day by any person.

Section 2. All parts or provisions of the Code that are inconsistent herewith are hereby repealed to the extent of, but only with respect to, the subject matter of this Ordinance. All other parts or provisions of the Code shall remain in full force and effect as heretofore adopted.

Section 3. If any sentence, clause, section, or part of this Ordinance is for any reason found to be unconstitutional, illegal, or invalid, such unconstitutionality, illegality, or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections, or parts of this Ordinance. It is hereby declared as the intent of the Borough that this Ordinance would have been


47 adopted had such unconstitutional, illegal, or invalid sentence, clause, section, or part thereof not
48 been included herein.


49 **Section 4.** This Ordinance shall become effective five (5) days after the passage thereof.


